### **CONNECTICUT LEGISLATORS PREPARE TO ADDRESS THE STATE'S DEATH PENALTY**

#### *Families of Victims Among Those Supporting Repeal*

(Washington, DC) Legislators in Connecticut are expected to vote soon on SB 280, a bill to replace the death penalty with a sentence of life imprisonment without the possibility of release. **On March 21, SB 280 passed the Judiciary Committee (24-19), preparing the way for votes in the Senate and House of Representatives.**

The bill would prospectively repeal the death penalty, and it has gained the support of over 179 victims' families and friends, who believe the state's capital punishment statute does not serve their needs for support or provide the promised "closure" after the loss of a loved one. A similar bill was considered by state legislators in 2011. Governor Dannel Malloy has pledged to sign the repeal bill.

Other states, including Maryland, Kansas, Kentucky and California, are considering death penalty repeal in 2012. If the bill becomes law, Connecticut will become the fifth state in five years to end the death penalty. Illinois (2011), New Mexico (2009) and New Jersey (2007) have recently voted to abolish the death penalty. In 2004, New York's death penalty law was declared unconstitutional and the last inmate was removed from the state's death row in 2007. Around the country, death sentences and executions have declined significantly since the 1990s.

**On March 27, NAACP President Benjamin Jealous, along with African-American leaders from across Connecticut, will be hosting a press conference concerning the pending legislation. The press conference will begin at 12:30 p.m. in Room 1C of the Legislative Office Building, 300 Capitol Avenue, Hartford, CT.**
